VISION STATEMENT

 - A. Roll Call: Arden, DeFazio, Gibson, Harding, Skala present

- 3. PRESENTATION
 - A. Logan Swain: Boy Scout. Proposing to construct 1-2 little free library's at AMRPD parks as Eagle Scout project. These consist of boxes where people can take and provide books. Logan would raise funds and provide the boxes, provide books, and maintain, but would need AMRPD to provide the location. Anticipates that he would install the boxed in early-mid October.
 - Arden open for motion. Harding motion to approve installation of two little free library's, one at Deterding Park, and another at a location to be determined. DeFazio 2nd. All approve.
 - B. Dane Wadle: Works for the California Special District Association, an advocacy/lobbyist group for special districts. Identified they have special interest in Assembly Constitutional Amendment (ACA) 1, and he is requesting, if the board so decides, we consider submitting a letter of support for ACA
 - 1. Mr. Wadle identified that ACA #1 would allow special districts to decide whether, instead of 2/3

votes, could get a 55% vote on ballot measures. Mr. Wadle identified that the amendment had failed in legislation, but they were expecting it to come back in January. Mr. Wadle identified AMRPD could submit the letter of support to him, and he would forward it to the representatives.

W. Harding motion to send letter supporting ACA 1. Motion dies due to lack of a 2nd. Following the vote, the board continued discussing. Board members DeFazio, Arden, and Skala identified they did not have sufficient information on which to approve the proposed vote. Board member Gibson identified she does not feel comfortable taking specific political positions without input from the public. Determined should be added as an agenda item for the next meeting.
