- D. **Sacramento Park Foundation** Attempting to get reimbursed but the State will not reimburse past invoices. Working on getting a loan and invoices cleared and paid out.

9. CORRESPONDANCE

- A. FEC Park Police See Report
 - a. Have staff continue calling non-emergency number for the golfer at Jonas.

10. OLD BUSINESS

- A. Subject: Review and select appropriate safety fill material for District playground.
 - a. No results for the testing of the material. The District is still waiting on the testing and results. Skala asks if we have to wait or if we can just vote and move forward. DeFazio asking if we can move rubber bark material to where we may be low. DeFazio poses the question if we are hurting ourselves in the long run if the rubber bark and wood chips mix. Grace says there is no urgency to get the test and that the Board can wait until the next meeting. DeFazio is concerned about with the level of the sand box at Jonas. Grace mentioned that it's a sand box and doesn't need to have fall attenuation. Grace mentioned that we should refill the sandbox with sand.

11. REGULAR CALENDAR

- A. Subject: Review and approve Jonas Larkspur Tennis Court refurbishment project.
 - a. Skala asked where this project came from and why we were not doing more at Crabtree. A member of the Community came to a board meeting asked for the turf to be made a priority. Grace mentioned that more part time maintenance staff had been hired on to free up the Maintenance Supervisor so that the irrigation at Crabtree could be made a priority. Grace asked for a report on the status of the Crabtree irrigation and booster pump.
 - b. The Jonas tennis court refurbishment would be half tennis and half pickleball to ensure that the court did not have double painted lines making play less confusing. Skala mentioned that tennis players can go to Swanston Park. Arden posed the question if we should install all pickle ball courts. Grace mentioned that we should try to enlist support from the community members in the Sierra Oaks Vista area. Doing projects that will help garner support will help. Arden mentioned that we should do projects at all parks to gain support. More should be done at Crabtree. Grace asked for the Board to meet and review a list of projects and funding sources. DeFazio asked if there was a way to make revenue off pickleball courts. Grace mentioned that we should think about making Jonas all pickleball and Crabtree all tennis. The demand for tennis is low compared to pickleball. Arden asked if the Board wants to make a decision now.
 - c. The Board has asked to get an estimate for 8 (eight) pickleball courts and to see what community members would like to do with the Crabtree tennis court.
- B. Subject: Review, Discuss, and initially approve Deterding Office Building HVAC replacement.
 - a. The main office HVAC system needs to be repaired. The unit is 20 years old, and the cost of the repair could be close to the cost of replacement. At this time, the District should look at getting the 3 HVAC units at Deterding replaced. The Community Centers HVAC system is 30 years old and the Activity Room is 20 years old. The Board asked to schedule a special meeting once 3 estimates are received to replace all three HVAC systems.
